

## **Notice of Public Hearing**

The Association of Monterey Bay Area Governments (AMBAG) will hold a public hearing regarding the final determination on the appeals received on the Draft 2023-2031 6th Cycle Regional Housing Needs Allocation (RHNA) Plan. Consistent with the requirements of the Brown Act, members of the public may submit written comments in advance of the meeting or provide oral comments at the meeting. Each appeal shall be heard individually before the AMBAG Board of Directors. The AMBAG Board of Directors will be asked to: (1) approve the final determinations regarding the appeals on the 6th Cycle Regional Housing Needs Allocation (RHNA), which were heard by the AMBAG Board of Directors at a public hearing on August 10, 2022; and (2) authorize staff to issue the proposed Final 2023-2031 6th Cycle RHNA Plan prior to Board consideration and adoption in October 2022.

The Final 2023-2031 6th Cycle RHNA Plan is scheduled to be released by September 23, 2022 pursuant to Gov. Code, § 65584.05(e). The AMBAG Board of Directors will hold a public hearing in October to adopt a final allocation plan. (Gov. Code, § 65584.05(g).)
